## **Fishing Regulations**

1. One day permits to fish in the Northeast Creek Reservoir are available by mail from the Louisa County Water Authority or may be purchased from commercial locations designated by the Superintendent. Requests by mail should be addressed to Louisa County Water Authority, P. O. Box 9, Louisa, VA 23093 and include the correct fee for each permit, the date(s) desired to fish and a self-addressed stamped envelope. Allow 7 days for delivery.

2. Fishing permit will cost \$2.00 per day per adult, and may be purchased up to 30 days in advance. Annual fishing permits cost \$10.00 per fisherman under the age of 65 and \$8.00 per fisherman over the age of 65. Annual permits are good for the day of purchase to the last day of the calendar year (January 1 – December 31). Fishing permits can be obtained at the Louisa County Water Authority business office during regular business hours or across from the Reservoir at the Northeast Creek Water Treatment Plant. Call the business office for additional purchase locations.

3. Children under the age of sixteen who are not required to have a State fishing license must have a Children's Permit which will be issued for .25 cents. The child must be accompanied by an adult responsible for their actions, welfare and safety.

4. No swimming, wading or bodily contact allowed.

5. No gasoline motors allowed on Reservoir; no petroleum products, toxic substances, or other pollutants of any type allowed on the Reservoir.

6. Fishing allowed only from boats and bank area designated for fishing by Louisa County Water Authority.

7. Fishing allowed from one hour before Sunrise and one hour after Sunset.

8. No trespassing on Water Authority property after posted hours.

9. Creel and size limits will be set and posted by the Virginia Game Commission.

10. Parking will be in designated areas only. No vehicles allowed on the Dam, Engineering Spillway, or other areas posted by the Authority.

11. Boats, automobiles and equipment may not be left on Water Authority Property after legal fishing hours.

12. Virginia State fishing license are required of all fishermen required by the law to obtain one. All boats must meet applicable State and Federal requirements for safety equipment, load capacities, and registrations.

13. Any person, upon request by any employee or agent of the Louisa County Water Authority or by any Local or State law enforcement official, must display his fishing license and day permit to the employee, agent or official.

14. Any person refusing to show his license, permit and/or identification upon request, or violating any of the regulations governing fishing at Northeast Creek Reservoir will have his permit voided and must leave Water Authority property immediately. Future issuance of permits to fish for any individual found in violation of these regulations will be at the discretion of the Louisa County Water Authority.

15. Louisa County Water Authority reserves the right to close the reservoir or any area of the same to fishing or other activities at any time for operational or other reasons.

LOUISA COUNTY WATER AUTHORITY OR LOUISA COUNTY ARE NOT RESPONSIBLE FOR INJURIES TO PERSON OR PROPERTY THAT OCCUR ON NORTHEAST CREEK RESERVOIR PROPERTY AT ANYTIME.
