A RESOLUTION TO APPROVE THE LOUISA COUNTY WATER AUTHORITY'S FISCAL IMPROVEMENT PLAN

WHEREAS, the Louisa County Water Authority is suffering from a variety of fiscal challenges that include an inadequate customer base, binding or informal contractual arrangements that constrain independence, increasingly expensive regulatory compliance standards, citizen lawsuits, and other factors, which are all compounded by a depressed national economy; and

WHEREAS, the Water Authority is presently unable to meet its recurring costs and anticipated expenses for necessary changes to its operations and infrastructure; and

WHEREAS, the Water Authority's Board of Directors have developed a Fiscal Improvement Plan, which outlines a way forward to address the challenges facing the Authority; and

WHEREAS, the Plan presents a variety of positive proposals, but without specific detail on how the proposals may be implemented, but requires that additional detail will be brought to the attention of the Board of Supervisors before implementation, as needed or requested; and

WHEREAS, the following items will be implemented immediately:

- Begin agreement rewrite negotiation
- Begin town customer assimilation negotiation
- Review and consider facility ownership issues
- Keep connection fees
- Begin drafting new County ordinances for review

- Use new pay structure for employees
